Right Relations

- The UUA no longer offering training sessions
- We will be organizing our own
- We have two people we could hire to lead: Reverend Lief and Reverend Paul
- The experience of new members needs to be taken into account
- These skills are important for building and maintaining our community both the UU community and our personal communities.
- It's important to our attracting a minister that we get our conflict resolution in order.
- For clarity, it might be best to use the term "Healthy Congregation" instead of "Right Relations"
- Everyone really likes Reverend Lief
 - She offered to come Friday night, meet with board on Fri, hold a meeting on Saturday all day, lead a service on Sunday, and run a workshop after the service - total cost would be \$2000 plus transportation

- This should be easily covered under the current budget as this is a ministry issue and can be taken from the ministry budget.
 - re: Budget: While we have some deficits, we're doing well in other areas and overall mostly on track
- This would give us tools to use on an ongoing basis
- We would have to do own policy on handling destructive members and destructive communications
- Concerns are that she is expensive and has a somewhat limited scope
- Difference between COSM and Right Relations Group
 - RR would be more trained.
 - COSM is more to support the minister than community conflict resolution.
 - RR would be focused on the larger community.
- We will need to be prepared for the fact that some things just can't be resolved.
- Group who met with Rev. Lief will meet with Rev. Paul later this week and make a recommendation.

Ministerial search

- Considered a Salary raise from 40k to 45k per year, or even up to 50k per year.
- Motion to increase to 45k made by Kathy E. Seconded by Donn. Motion passed.

This year's Solstice Fundraiser will likely be less successful than last time but hopefully still worth it

- Kathy A makes a motion to participate. Kristen seconds. Motion passed.

Auction Fundraiser

- We have made this event online in the past few years but it was originally an in person event. Which should we do this year?
- As an in person event, it helps with community building as well as providing funds.
- Let's have two events, one online and one in person.
- In addition, we could let local artists sell during coffee hour and take a cut of the sales.
